


Please follow these instructions to create a standard multiple-choice question using the "*Multiple choice: random correct answer*" template.

Setting Up the Question


 First, sign into <u>PrairieLearn</u>, and then click on the "Question" tab located in the black bar at the top of the screen.



o Then, click the "+Add Question" button, under the blue bar on the far right of the screen.




 Next, create a title and a unique identifier for your question. Remember to create a generic, standardized title that students will see. The Question Identifier (QID) should be recognizable to aid in assessment creation. The QID must have no spaces and only use letters, numbers, dashes, and underscores (e.g. "MC-business-principles" or "TF_Cog-Develop-Theory")






o Click the dropdown menu under "Start from" and change "Empty question" to "Template".




 Next, click the dropdown menu under "Template", and select "Multiple choice: random correct answer" and click create.






 After creation, the question starts on the "Preview" tab. Next click the "Files" tab to the left of the "Preview" tab on the upper left side of the screen.




There's only one file that needs to be edited: the "question.html" file. Click on the "Edit" button
to the right of the question.html file.



If you click the "question.html" preview link on the left above, you can still access the code editor by clicking the "Edit" button on the right side of the blue bar.



o In the question editor window, the code elements are identified by color designations and each line is numbered on the left side of the screen:

Editing the Question


After using the template to create your question, the question editor window will have the basic formatting necessary to create a multiple-choice question with 1 or more correct answers and 3 or more distractors.





Common Issues & Tips for Success

Small changes in the coding elements can cause issues and errors. Here are some common mistakes and tips for success.

o If you mistakenly delete a part of a code, a red X icon will appear next to the line where the issue is. Hovering over the icon will provide information regarding the issue. In this example, I deleted the ">" character from the end of line 12. Because part of the closing tag is missing, the system is reading the error in line 13. Replacing the missing character will fix the problem.

For this example, I started a new line for each piece of information I modified for this question; this has no effect on the formatting or display of the student view of the question.
